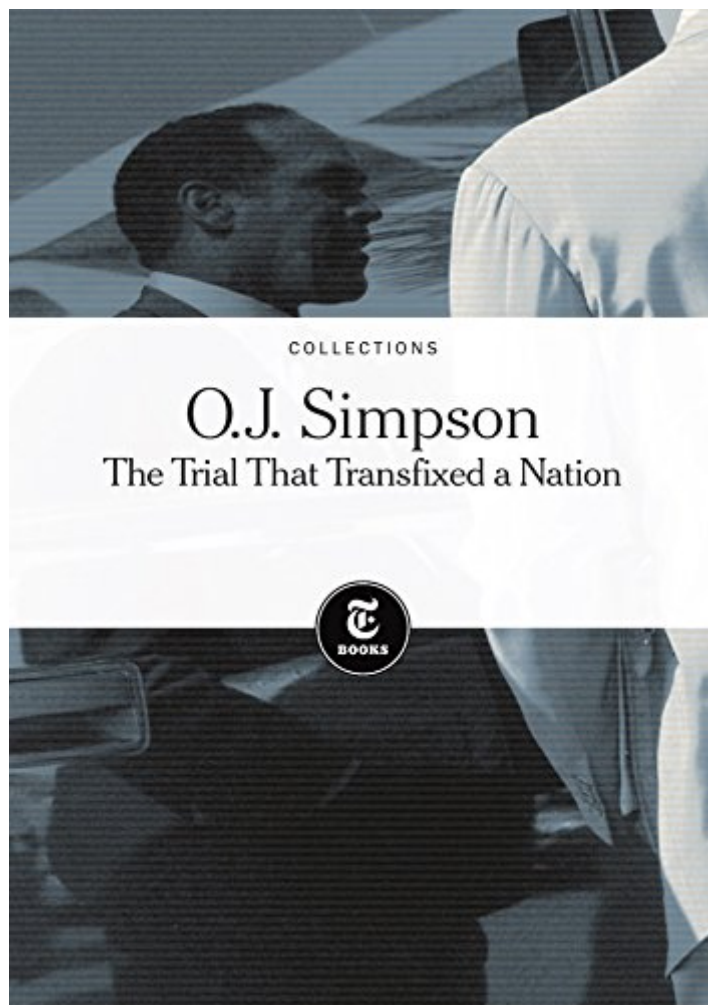

The subsequent murder trial, dubbed "the trial of the century," became one of the longest-running, most widely covered and most racially divisive court cases in U.S. history.
