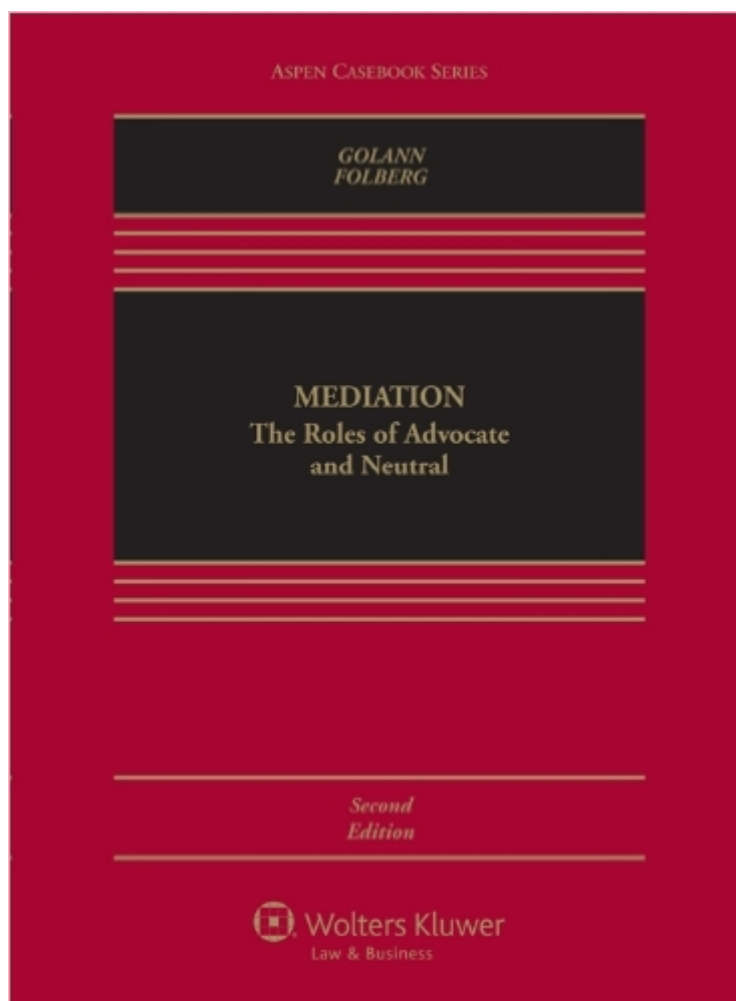

New exercises include a cross-cultural business role-playing scenario to give students a sense of the actuality of mediation. A new DVD with commercial mediators mediating an international business dispute, which is organized into short chapters that show a particular stage in the process or technique, ranging from a pre-mediation meeting to the use of decision analysis and impasse-breaking techniques. *Mediation: The Roles of Advocate and Neutral, Second Edition*, concentrates on the practical, real-world aspects of mediation rather than the theoretical or academic in order to better prepare students for their role as lawyers in the mediation process.
