## Customer Reviews

Some of the case briefs are fairly accurate summaries (e.g., Van Gorkom), but most vary from bad to awful. The cases that trace the development of Revlon and Unocal duties are particularly bad, and completely misrepresent what's important about Revlon, Time-Warner, and QVC, amongst others.

I don't think it entirely replace the value of reading the cases in the book, but it's nice to have on-hand for a quick reference, during review, and in class.

This is a fantastic supplement to the text if you are taking the class or a great stand-alone study guide for the bar if you have not taken the class.
