

I purchased these my 1L year to supplement my supplements - the Glannon E&E & Multiple Choice Guide (recommend both) and a Gilberts Outline (would not recommend). They made for a very handy review of the basic rules (which required heavy memorization) and provided useful hypotheticals. I wouldn't rely on them for explaining the law (Glannon will always be best), only for memorizing the rules (which will save you time you might otherwise spend flipping through the FRCP during the exam). A bit of advice: I see these and similar boxed flashcard sets frequently unopened and unused in the book donation pile at the end of the semester, which I think is more a matter of students overbuying study aids (I've certainly been guilty) than the quality of the cards (I can only say for Civ Pro). Make sure you know the format of the exam (open book or closed, with or w/o multiple choice) and select your aids accordingly.

These flash cards are extremely useful for going through the in and out of procedure. Lots of hypos

and covers the landscape of the material well. Occasional humor keeps it lively. Expensive but worth it.

I'm a big fan of the Law in a Flash series. These cards make for a great supplemental study aid. The best feature, in my opinion, is the "scenario" questions. These are like mini-fact patterns designed to get you thinking about one particular issue. I've found these to help get my mind around particular topics in a format conducive to an essay style exam (which all of my instructors use). I do wish that the cards had some more "concept w/definition" cards (where one side gives a word, concept, or issue, and the answer side has a rote definition), but it's not a major issue. I also do think that in this particular series (CivPro) there was a bit too much repetition. Honestly, I believe they could have pared it down to one box if they tried hard, but maybe having that repetition is useful to some.

These flash cards are a great study aid. had the best price I could find...a lot cheaper than the law book store. The fact patterns are kind of corny (they use funny names etc.), but interesting.

Great, humorous hypos to help practice rule application. Good, brief restatements of rules. Very helpful for exam preparation this semester.

I was struggling with Jurisdiction and these cards helped alot. No only do they quiz you but give you explanations so you can use it to review easily.

Great hypotheticals to simulate discussion or test prep. Would highly recommend to other 1Ls hoping to do well on their exam.
