

I read this book in one sitting. It is a must read. What I liked the most about the book is that it is a compilation of the stories of the people involved in litigation cases. Litigation can seem mundane or protracted or steeped in technicalities. But the author aptly points out that behind just about every case is an interesting story about the litigants or the attorneys involved. She also successfully shows how leaving decision making to a judge rather than settling can result in unintended consequences.

stories point out, the way people act and conduct themselves can be truly amazing (and sometimes just plain scary). Most of all, lawyers are people just like us ... made up of life's experiences and packaged uniquely and individually. A great read ... highly recommend it!!

Stick and Stones is a great read, imparting important life lessons in a highly engaging manner and, most important, encouraging the reader to look at the world with a different perspective. Lyons is no sentimentalist when she lays out the cases that punctuate the bookâ "here we see humanity in all of its glory, truly the good, the bad, and the ugly. What makes this work different than a family court version of CSI is that Lyons doesnâ ™t seem to close a case when the gavel comes down for a final time. Instead, she opens another investigation, this time with a humanistâ ™s precisionâ "to understand what happened and why and, to our benefit, what can be learned from it. Lyons, like many great lawyers, is also a gifted storyteller. Just as she no doubt captivates her audience juries by painting florid pictures, so too does she ably fill this book with engaging tales. She recognizes, thankfully, that people process information, learn, and are persuaded by stories. And, boy, does she tell some doozies. The book is organized with discrete stories so that the reader can put it down at any time. I for one, however, hoovered up story after story like it was a page-turner novel. While I enjoyed the stories and nodded at the life lessons they reflected, I was most affected by the ability of Sticks and Stones to get me to look at lifeâ "my day-to-day and the larger humanityâ "from a different perspective. Many of us get into a rut and tend to acquire a bit of tunnel vision over time, seeing things from a single viewpoint and including more navel gazing than is healthy. Lyonsâ ™ book provides just the right jolt to cause the reader to examine things from a different angle. I found that healthy and I am looking forward to being jostled again a "when the author has collected the next batch of life lesson stories to publish.

If Aesop's Fables and Chicken Soup for the Soul has a modern day baby, this would be it. Human nature is an interesting thing. At it's finest, it can foster world peace. At it's worst, it could destroy an empire. This book shows life lessons - some learned the hard way - and how they can either be learned and retained, or ignored and forgotten. You don't want to be in that latter group. It easy to make fun of lawyers, but after reading about the emotional and sometimes heartbreaking cases that they have to handle with poise, dignity and objectiveness on a daily basis, you will find a new found respect for the family lawyer.
